**New Customers:** All new accounts are on a prepay basis via cash, cashier's check, money order, credit card, company check or bank/wire transfer. COD is not accepted.

**Drop Shipping:** Drop shipping is available for our dealers in good standing. At this time, we charge no fees for drop ship orders. This may change at a later date.

**NSF Checks:** Any checks returned to VIBE Motorsports LLC unpaid are subject to a \$30.00 processing fee or 5%, whichever is greater. If two or more checks are returned for any reason, the account will be placed on cash or money order only.

**Damage Claims:** All damage claims must be reported within 24 hours of receipt of the shipment. All packing material must be kept by the recipient so they can be investigated by the carrier. Contact us immediately with photos of the damaged item(s) and packaging to proceed with the claim. If shipping label is provided by the dealer, the dealer is responsible for all damage claims that may occur.

**Prices:** All prices are subject to change with prior notification. Dealers must follow the MAP (Minimum Advertised Pricing) otherwise their dealer account may be forfeited. All price lists published by VIBE Motorsports or its affiliates pertain to dealers only. Price lists are not published in any effort to affect the resale pricing.

**Terms and Policy, Non-Compliance:** Any action of non-compliance by the dealer to the terms and policies stated will be considered by VIBE Motorsports LLC as a voluntary forfeiture of dealer account status.
